## 1. Welcome & Apologies

1.1 All members were present and welcomed.

## 2. Minutes of Previous Meeting

2.1 The minutes of the meeting held on 5 August 2025 were agreed.

## 3. Update from Main Committee Meeting

- 3.1 DS passed on the T&F section's disappointment that SAL was not better supported by the endurance section. The SAL team just missed promotion, and this may have been achieved with better representation in the longer distances by the endurance athletes. PD said he would try to get better support next year if dates are given to him well in advance.
- 3.2 Karen Clarke has been appointed as Welfare Officer and will be supported by JS for 12 months.

  DS has given one year's notice to the main and T&F Committee on standing down.
- 3.3 We will need to find replacements from the T&F Committee for JS and DS to sit on the main Committee.
- 3.4 DS reported that the Main Committee have been discussing a joint awards evening end of January, date to be confirmed. They are looking for larger venues than CRFC provided last year. This led to a discussion on T&F awards. LG, JS, JC and TB will form a T&F working group to help arrange the evening. Awards categories will be XC Girl and Boy for U11/13/15/17; T&F Girl and Boy for U13/15/17; Team Manager XC and T&F; Athlete of the Year Girl and Boy; SAL Male and Female, which is 20 awards in total. KM said no need for EMAC award.

### 4. COBRA team and EYAL/SAL update

- 4.1 DS asked for opinions on whether we join with Braintree next season, as Mike has asked for CHAC to support them for another year. In terms of team depth, Braintree helped in SAL, but it was felt that they are not needed for EYAL. Furthermore, given the lack of on the day communication from Braintree TMs and athlete no-shows, the combined team was stressful for our EYAL TMs. Hence the Committee decided that we would make a joint team for the SAL but not EYAL.
- 4.2 We have been asked to host an EYAL fixture in 2026. Given the new age groups, we will need to buy equipment as per the new specifications. RT will email the list, which JC would like to

receive – as the army will supply this. We also provided feedback on the timetable issues to the EYAL Committee. We should make sure we have representation at the EYAL AGM, which SAL have split the division into North and South.
